



2011-2012 FC Alliance Scholarship Application



FC Alliance provides a limited number of need-based scholarships based on total household income, using the same income guidelines as the National School Lunch Program. FCA scholarships are available to help defray the club registration fee. The minimum club registration fee is \$55 per player. FCA is a volunteer run organization and the family of a scholarship recipient is required to either provide 5 hours of participation in team and/or club volunteer opportunities or pay the \$50 Volunteer Fee which all members pay. The volunteer opportunities are available all year and must be satisfied prior to the end of the regular season. Failure to do either will result in suspension from club participation.

Instructions

Please use the Income Eligibility Chart on the next page as a guideline to determine whether you may be eligible for an FCA scholarship. We understand that families may currently be experiencing some unique circumstances that should be considered in addition to the household income. If your household income exceeds the salary levels on the Income Eligibility Chart, please attach an additional page explaining your unique situation.

Documents Needed

- Completed 2011-2012 Scholarship Application
 - Copy of "Letter of Verification Results" provided by the participant's school confirming the qualification and receipt of free or reduced lunch at time of submission of the Scholarship Application.
- OR-
- Copy of IRS Form 1040 (or Form 1040s) for the most recently ended calendar year which claim participant as a dependent on their tax return (i.e. if married filing separately both parent's Form 1040s must be included, if divorced the parent who claims the participant as a dependent for the most recently ended calendar year must be provided), including all W-2s, 1099s and other documents that support total annual income.

Please be aware that incomplete applications – such as applications that are not supported by a copy of a Federal Income Tax Return – may not be considered.
